Referring to Article 43A paragraphs (1) and (2) of the Financial Services Authority Regulation Number 14/POJK.04/2019 concerning Amendment to POJK Number 32/POJK.04/2015 concerning Capital Increase in Public Company with Pre-Emptive Rights and as resolved by the Extraordinary General Meeting of Shareholders of the Company dated June 30, 2025, in relation to the exercise of Capital Increase Without Pre-emptive Rights ("**Capital Increase Without Pre-emptive Rights**"), the Company intends to issue 514,710,000 new shares with the nominal value of IDR100,- per share, with the implementation schedule as follows:

- Exercise of Capital Increase Without Pre-emptive Rights: 15 January 2026
- Announcement of Capital Increase Without Pre-emptive Rights Completion: 20 January 2026

Capital Increase Without Pre-emptive Rights shall be exercised at a price of IDR153,- per share.
